**Provisions in the Bylaws of the International Cemetery, Cremation and Funeral Association as they pertain to Individual/Regular Membership**

**Article III: Membership**

**Section 2.b.** (2) Each regular member shall designate no more than (2) individuals who are engaged in business in Section 2.b.(1), to represent, vote, and act for the members in the affairs of the association. If a second individual is designated, the regular member shall pay additional dues for that individual.

**Provisions in the Bylaws of the International Cemetery, Cremation and Funeral Association as they pertain to Individual Associate Membership**

**Section 2.b. Other Members**

The following membership classes shall have no vote or be eligible to hold office in this association:

**(1) Associate member:** Any individual, firm, corporation, municipality, and religious and fraternal organization affiliated with a regular or supplier member may become an associate member of this association upon a recommendation of a regular member. In the event that an associate member shall leave his/her employment or active affiliation with the regular member or supplier member who recommended that person for membership, then that person's associate membership shall immediately cease and terminate. Nothing in the preceding sentence precludes a person from filing a new application upon becoming affiliated with another member.
